Road Safety – Improper inspection on the SLD / SLF Device in Transport Vehicles - Issue of Instructions to further strengthen the quality of vehicle inspection for FC – Regarding.

You are aware that while conducting vehicle inspection for FC various crucial parameters are being checked to verify not only the Road worthiness of vehicle but also Road Safety aspects of the vehicle.

Complaints are being received with respect to few offices that while conducting vehicle inspection for FC utmost care is not being taken by few MVIs and the same on the part of some RTOs while doing the super checks.

One such lapses is that at the time issue of Fitness Certificate, the functionality of SLD / SLF device, Genuineness of its certificate are not being verified properly, in addition to other Road Safety related aspects like break light functioning, fixation of dazzling light, reflective tapes, tyre conditions, etc.,

Such omissions will have a direct bearing on the Road Safety and they will be posing great challenge in bringing down the number of accidents.

You are aware of the fact that in the year 2023, out of the total number of 18,074 fatalities, 17,339 fatalities (96%) had happened only due to fault of driver (Major reason is being over speeding).

As per the United Nations Development Program (UNDP) Agenda on SDGs (Sustainable Development Goals) published in 2015, number of Road accidents were to be brought down to 50% by 2020 and to 0% in 2030.

Accordingly, in the second cited reference, annual target for the reduction of Road accidents in each and every district for the period from 2023 to 2026 was circulated to all districts.

Proper functioning of SLD / SLF and Genuineness of SLD certificate in respect of Transport vehicles is the foremost concern which needs to be ensured while conducting vehicle inspection for FC. By ensuring this we can certainly bring down the number of accidents significantly.

It is learnt that some of the MVIs and RTOs are not properly verifying/ over checking the proper functioning of SLD / SLF and in ascertaining the Genuineness of certificate issued. So, instructions are hereby issued for proper checking on the Genuineness of SLD certificate and its (SLD / SLF) proper functioning.

All Zonal officers are instructed to monitor this.

I am to invite your attention to the reference 2nd cited wherein the Supreme Court Committee on Road Safety(SCCoRS) has decided to assess the extent and quality of the action taken by the States to Implement the directions issued by the Committee till date. In this regard, the Chairman of the SCCoRS has conducted a Zoom Meeting on 01.05.2023 with all State Chief Secretaries, Transport Commissioners and other stakeholder departments. In this regard, M/s Delhi Integrated Multi- Model Transit Systems Ltd., Delhi(M/s DIMTS, Delhi)

has been appointed as Consultant to carry out this assessment of the State of Tamil Nadu on behalf of the Committee.

Thiru. D.B. Srinivas, Vice- President – Transport Planning, DIMTS has conducted a Zoom meeting on 01.05.2023 at 2.30PM with the Transport Commissioner of Tamil Nadu. In this session the Vice President has insisted that annual target should be set for reduction of road accident fatalities in the State from the year 2023 - 2026.

As directed by the SCCoRS, the target shall be fixed for reduction of road accident deaths in the year from 2023 - 2026 taking the year 2019 as the base year are fixed and communicated to all stakeholder departments.

Hence, you are requested to draw appropriate action plan and monitor the steps taken to reduce the road accidents deaths as per the targets communicated in the annexure enclosed with this letter. The action taken in this regard may please be communicated to this office on or before 31.05.2023.
